MCWD Board President, Directors, and General Manager:

I am sorry to hear of the resignation of Ken Nishi from the Board and I'm grateful for the years of service he has given to serve our community.

I would like to recommend Tom Moore to fill his seat on the MCWD Board of Directors for the following reasons:

- 1) Had this resignation come prior to the November 2010 election, just 3 months ago, Tom Moore would have received enough votes to remain on the Board. Tom Moore is the only applicant to fill this vacancy whom the public recently voted for; he is the only applicant with a voter mandate for this specific position—1,712 MCWD ratepayers cast their vote for Tom Moore. I don't see how the Board could justify selecting another applicant with this kind of direct public support.
- 2) Tom Moore is the best choice to maintain Board continuity. With 17 years of continued elected service on the MCWD Board of Directors that ended less than 3 months ago, there would be no interruption or disruption of Board business with Tom Moore's appointment. Bringing another applicant up to speed would be very time-consuming, especially for an applicant with no prior MCWD Board experience.
- 3) With MCWD at the center of the Regional Water Project on the verge of drilling its first 2 wells, the Board needs its most experienced players on the field. With the loss of Ken Nishi's 20 years of Board experience, only Tom Moore has the credentials equal to Ken Nishi. As a MCWD ratepayer, that's the level of representation I want as my water district moves forward on the largest and most strategic project it has ever embarked.
