- 9. Marina Coast Water District Groundwater Sustainability Agency Matters:
 - A. Staff Reports:
 - 1. Receive a Report on the State of MCWD's Groundwater Resources:

Mr. Patrick Breen, Projects Manager, introduced this item. Vice President Moore questioned the Army's TCE cleanup and if it affected any of the District's wells. Mr. Breen answered that the TCE contamination was in the shallow aquifer and was not detected in the District's deeper wells. Vice President Moore inquired on the population growth numbers. Mr. Keith Van Der Maaten, General Manager, answered that the numbers came from the FORA Base Reuse Plan. Director Cortez suggested that in the future, staff clarify what constitutes the projected water needs of 9,000 AFY so everyone understands what it entails.

2. Receive a Report on Groundwater Sustainability Plan Projects:

Mr. Van Der Maaten introduced this item and briefly explained the most significant efforts that that are currently underway. Those projects include: Regional Urban Water Augmentation Recycled Water Project; Armstrong Ranch Stormwater Capture and Reuse Report; Airborne Electromagnetic Survey Project; "Three Party Memorandum of Understanding (MOU)" Project; and, Production and Pumping Database Improvement Project.

Ms. Margaret-Anne Coppernoll, Marina resident, commended the District on the work they are doing with the electromagnetic survey and following up on the Rosemary Knight study.

Mr. Wegley introduced this item He shared maps showing the Groundwater Sustainability Agency (GSA) areas for the Monterey subbasin and the 180/400 subbasin. Vice President Moore gave a brief background on the Sustainable Groundwater Management Act (SGMA) and explained the GSA process.

Vice President Moore made a motion to appoint himself and Director Shriner as the District representatives for GSA discussions and Director Lee as the alternate. Director Cortez seconded the motion. The motion was passed.

Mr. Roger Masuda, Legal Counsel, stated that there are specific directions that there must be community/public involvement. Director Shriner clarified that the technical and advisory committees are for the entire service area. She also stated that she had a recommendation to the "Initial List of Beneficial Uses and Users of Groundwater" and had a contact for number 7, California Native American Tribes. Director Shriner suggested adding the Seaside Watermaster, the Sanctuary, and the Army to the list.

Vice President Moore made a motion to direct staff to put together a recommendation for the Board to consider. Director Shriner seconded the motion. The motion was passed.

4. Consider Adoption of Resolution No. 2017-GSA02 to Approve a Coordination Agreement for Groundwater Sustainability Planning for the Salinas Valley Groundwater Basin Proposed by the Arroyo Seco GSA (City of Greenfield and Clark Colony):

Mr. Van Der Maaten introduced this item stating that the Arroyo Seco GSA approached the District with the coordination agreement that basically states the GSA's agree to work together and support each other towards preparing and adopting coordinated multiple groundwater sustainability plans for the Basin. He noted that Arroyo Seco's interim legal counsel, Pamela Silkwood, was present to answer any questions. Vice President Moore questioned the title of the agreement and suggested calling it an inter-basin cooperation agreement. He also questioned Section IV, paragraph 4, and asked if there were objections to removing that paragraph.

Vice President Moore made a motion to adopt Resolution No. 2017-GSA02 and change the title of the agreement to <u>Inter-basin Cooperation Agreement</u> for Groundwater Sustainability Planning for the Salinas Valley Groundwater Basin Proposed by the Arroyo Seco GSA (City of Greenfield and Clark Colony) and remove paragraph 4 of Section IV, however, if a variant of paragraph 4 is suggested by others, it be brought back to the Board for consideration. Director Shriner seconded the motion. The motion was passed.
