# Draft Minutes Special Budget and Personnel Committee Meeting

# April 24, 2020

# 1. Call to Order:

The April 24, 2020 special Budget and Personnel Committee meeting was called to order at 9:05 a.m. by Vice President Shriner. In attendance were:

- 2. Public Comments on Any Item Not on the Agenda:

3. Approve the Draft Minutes of the February 11, 2020 Meeting:

Director Cortez made a motion to approve the minutes of February 11, 2020. Vice President Shriner seconded the motion. The minutes were approved by a vote of 2-Ayes (Cortez, Shriner), 0-Noes, and 0-Absent.

4. Consider Recommendation to the Board of Directors to Approve the Restructuring of the Accounting Department and the New Classification, Job Description and Salary Range for an Accountant:

Mr. Van Der Maaten introduced this item. Ms. Cadiente explained the need for the restructure of the accounting department and how this additional position would be beneficial to the District. Mr. Van Der Maaten noted that the Employees Association reviewed this restructure and was agreeable with the suggested changes. Director Cortez and Vice President Shriner asked clarifying questions.
