Draft Minutes Budget and Personnel Committee Meeting

September 7, 2021

1. Call to Order:

The September 7, 2021 Budget and Personnel Committee meeting was called to order at 6:34 p.m. by President Shriner. In attendance via Zoom teleconference were:

- Committee members: President Shriner and Director Cortez
- Staff: Remleh Scherzinger, Kelly Cadiente, and Paula Riso
- Public members: None
- 2. Public Comments on Any Item Not on the Agenda:

There was no public comment.

3. Approve the Draft Minutes of the August 3, 2021 Meeting:

Director Cortez made a motion to approve the minutes of August 3, 2021. President Shriner seconded the motion. The minutes were approved by a vote of 2-Ayes (Cortez, Shriner), 0-Noes, and 0-Absent.

4. Receive a Covid Update:

Ms. Cadiente gave a brief update noting that staff filled out a survey for Government Reimbursement and explained that the reimbursement is for water delinquencies only and does not include sewer or irrigation. She noted that the funds were expected to be disbursed in November and the District was looking to receive about \$134,000. Ms. Cadiente stated there would be more details to come.

5. Receive Information regarding the District's Investment Policy/Legal Expenses:

Ms. Cadiente briefly explained how the District's Investment Policy worked. President Shriner asked for a copy of the Investment Policy. Mr. Scherzinger reviewed the District's legal expenses. Director Cortez asked to discuss a breakdown of legal costs in closed session.

6. Update on the District Engineer Recruitment:

Mr. Scherzinger stated that the District Engineer was successfully recruited and would be starting on September 20<sup>th</sup>.

7. Identify Agenda Items for the Next Committee Meeting:

Director Cortez inquired if the beach office staff feels accommodated with regards to Covid. Mr. Scherzinger answered that he felt they are satisfied with the District's response to their needs. President Shriner asked for a synopsis of the Ord Community cost centers, and the surcharge history and any options available.
