Detailed Description: Tim Buhl began employment with the District in 2001 as a Meter Reader. From the beginning, Tim has applied himself with a great deal of enthusiasm and energy. During his first 13 months working as a meter reader Tim studied for and obtained his Distribution Operator Grade I Certification.

In 2002, Tim was transferred to the Operations & Maintenance Department from the position of Meter Reader to Systems Operator I. Upon his arrival, Tim promptly applied himself towards achieving certification in water treatment. Tim's steadfast pursuit of higher certification in the Water profession is impressive and to be commended. Mr. Buhl has passed the following examinations:

- 2003 Water Treatment Grade I
- 2004 Water Distribution Grade II
- 2007 Water Distribution Grade III
- 2009 Backflow Prevention Assembly Tester Certification
- 2010 Cross Connection Control Specialist Certification

As a result of Tim's achievements, he was promoted to Systems Operator II in 2007. Following completing the required training and certification, Tim was appointed as the Cross Connection Control Specialist for the District in 2010.
