## Resolution No. 2011 - 07 Resolution of the Board of Directors Marina Coast Water District Approving a Memorandum of Understanding Between the Teamsters Local 890 and the Marina Coast Water District

WHEREAS, the effective date of the MOU and all changes will be retroactive to July 1, 2010.
