Denise Duffy & Associates (DD&A) offers this Statement of Qualifications to provide on-call environmental services to Marina Coast Water District (MCWD) to extend our existing on-call contract with MCWD. Our ongoing and continual work with MCWD has provided DD&A with an unmatched understanding of the District's projects, issues, constraints, and opportunities. DD&A can provide local and immediately accessible highly qualified staff, thereby allowing for expeditious initiation of individual projects. The following provides additional highlights of DD&A's unique qualifications for this On-Call Contract.

## DD&A's Relevant Experience and Qualifications Highlights

- DD&A is a full-service firm with experienced leaders in water supply planning, California Environmental Quality Act (CEQA) and National Environmental Policy Act (NEPA) documentation and experts in natural resource regulations, including the Federal and State Endangered Species Acts, Clean Water Act, California Coastal Act, and California Fish and Game Code.

• DD&A fully understands the complex relationships that exist among agencies participating in water and infrastructure projects in the Monterey County area. We have an excellent rapport with regulatory agencies including the State Department of Public Health, California Department of Fish and Game (DFG), U.S. Fish and Wildlife Service (Service), U.S. Army Corps of Engineers (ACOE), and the Regional Water Quality Control Board (RWQCB).

DD&A has full geographic information system (GIS) capabilities and expertise, and can provide air quality and greenhouse gas analysis services in-house, if needed and desired. DD&A also has a full staff of biological experts whose expertise is outlined in the following section.DD&A's Natural Resource Division (NRD) biologists are extremely skilled in the identification of locally-occurring special-status plant and wildlife species and sensitive habitats occurring in the Monterey Bay region. The NRD has been successful in acquiring required State and Federal resource permits for a number of projects on the former Fort Ord and Monterey Peninsula.

- DD&A's full staff of biologists holds current Federal recovery permits for both the California red-legged frog and the California tiger salamander, State Scientific Collection Permits authorizing handling (capture and release) of all mammals, reptiles, amphibians, and freshwater/terrestrial invertebrates. (DD&A is the only local firm with this advantage).
- DD&A skilled biologists have over ten years of hands-on experience working on the former Fort Ord military base, including extensive survey work within areas of the District's potential impact area (representing cost savings to the District), and staff that has received training in recognizing Munitions and Explosives of Concern (MEC) required for survey work in areas of the former military base.
- Biologists at DD&A maintain excellent rapport with regulatory agencies, including the DFG, Service, ACOE, and RWQCB. DD&A biologists are skilled in identifying the need for, as well as preparing applications, obtaining, and implementing, environmental clearance permits from these agencies.
- DD&A biologists have provided pre-construction, construction-phase, and post-construction biological monitoring, including surveys for all locally-occurring special-status plant and wildlife species, for over 15 projects on the former Fort Ord within the last five years.
- DD&A biologists are also highly knowledgeable of CEQA and NEPA, as well as other environmental regulations including the Federal and State Endangered Species Acts, Clean Water Act, California Coastal Act, and California Fish and Game Code.
